Wellness Visit vs. Physical Exam: How Does it Work with Medicare?

Physical exams: You know you're supposed to get one every year. But did you know that Medicare doesn't cover what you might think of as a traditional physical exam? However, Medicare does cover other types of preventive care to help you stay healthy and prevent illness. The following is a breakdown of the types of visits and services Medicare covers 100% and what Medicare does not cover. This is intended to help you make sure you know what you need to know, before you make your next appointment.

If You Are New to Medicare you can have a "Welcome to Medicare" Preventive Visit

This is also known as the Initial Preventive Physical Exam.
Although this is often referred to as a physical exam, the purpose is actual to create a personalized plan and checklist for you. It may not include some of the services you received before you enrolled in Medicare, but it does include:
A review of your medical history and your health-related social history

- Counseling about and recommendations for preventive services, screenings and immunizations
- Height, weight and blood pressure measurements
- A calculation of your body mass index (BMI)
- A simple vision test
- A review of your potential risk for depression and your level of safety
- Referrals to other care, if necessary

Does Medicare cover it?

Yes. However if you doctor recommends other tests or screenings you may have expenses.

If You Have Been a Medicare Member for 12 months or longer:

You can have a Yearly "Wellness" visit at no cost, and your provider will:

- Develop or update your personalized prevention plan/checklist
 - Conduct a health risk assessment
 - Create/update a list of your current health care providers and medications
 - Take height, weight, blood pressure and other routine measurements
 - Discuss your screening schedule (checklist) for appropriate preventive services

Does Medicare cover it?

Yes, annually (but if your doctor recommends other tests or screenings you may have expenses).

OR

Physical Exam, which often have additional costs:

• A physical exam and/or tests that do not directly treat an illness are included in this visit. However, tests or screenings your doctor performs during physical exam might NOT be covered by Medicare as an annual preventive service.

Does Medicare cover it?

No. Medicare does not cover what is traditionally known as a "physical exam". But you can still get an exam and pay for the valuable service, according to your plan's coverage for doctor visits and tests.

Helpful Guidance to avoid unexpected bills:

Visit a doctor that accepts Medicare assignment. Experienced Medicare providers know how to bill for services to Medicare; follow Medicare guidelines; and know how to provide no-cost preventive services to you. Scholarship Committee Report

UCSC Giving Day was held on February 28 and there was fierce competition this year with 160 groups and organizations registered to participate. The Retirees Association ran two campaigns and raised a total of \$25,765. The UCSC Retirees Association Bruce Lane Memorial Scholarship Endowment Fund placed #32 out of 160 in fundraising with \$4,790 received from 55 donors, a \$250 prize for going over 50 unique donors, and \$10,080 in matching funds for a total of \$15,120. The Silver Slug Award Endowment Fund placed #46 out of 160 in fundraising with \$3,145 from 31 donors and \$7,500 in matching funds for a total of \$10,645. Thank you to everyone who donated on Giving Day and helped to build these endowments which will support student scholarships in perpetuity.

As of January 2018, here is the total amount of contributions to date for each of our funds:

Silver Slug Award Endowment Fund \$35,244.58 UCSC Retirees Association Bruce Lane Memorial Scholarship Endowment Fund \$103,785.78 UCSC Retirees Association Bruce Lane Memorial Scholarship Current Year Fund \$7,219 We are looking forward to the Scholarship Luncheon at the Arboretum on Wed. May 2nd. Eight \$1,000 scholarships for military veterans will be given, including three memorial scholarships, which are as follows:

- Awarded to **Oleksandra Keehl,** in memory of Mary Joan Rodriguez, contributed by Nancy & Roland Pascal
- Awarded to **Ethan Slattery**, in memory of LTC Joseph E. DeDera, contributed by Maxine Lane.

The five other military veteran students to receive scholarships are: Benjamin DeJarnatt, Julie Howell, Christopher Ivins, George Leece, and Spencer Smoot.

In addition, the first Silver Slug Award scholarship of \$2,000 will be awarded to **Tony Soto**, a full-time employee in the Community Safety Program. He began his UCSC student career in fall 2017 as a community college transfer and is majoring in Legal Studies. Tony's goal is to complete his undergraduate degree program by June 2019. The UCSC Retirees Association is pleased to support a staff member who is pursuing a degree while working. Go Slugs!

The Lime Kiln Tour is rescheduled for Sat. May 19th 10:00am – 12 noon



Admission is FREE, but you must register. A \$5.00 donation to Friends of the Cowell Lime Works Historic District is suggested and much appreciated. (payable in cash at check-in). Limited to 30 people.

This is a walking tour of the historic Lime Kilns on the UCSC campus. It will be led by Frank Perry, a UCSC graduate who has worked in the museum field for some 40 years. In 2007 he co-authored the book, "Lime Kiln Legacies: The History of the Lime Industry in Santa Cruz County." For the past ten years he has served as president of the Friends of the Cowell Lime Works Historic District. He helped organize the first ever Conference on Lime and Lime Kilns in California History and two Santa Cruz County History Fairs. He presently serves as curator of the Capitola Historical Museum. Frank will lead us on a leisurely loop through the Historic District, exploring the pre-UCSC history of the site. We'll learn about the historic buildings and kilns, how lime was made, and why it was important. Even people very familiar with the campus are sure to learn something new.

The Castro Adobe Tour will be rescheduled sometime in early June, keep an eye out for an email announcement when it is confirmed. Located in Larkin Valley near Watsonville, the two-story Castro Adobe is one of the finest examples of a rancho hacienda in the Monterey Bay area. Local non-profit organization "Friends of Santa Cruz State Parks" is leading a multi-year restoration effort to preserve and interpret the Castro and is partnering with California State Parks to open the adobe as a State Historic Park. The Castro Adobe will be the first State Historic Park in South County.
