Open Enrollment Information Concerning Medicare Retirees and Kaiser

Active employees, even those that work past age 65, are able to select Kaiser HMO as a medical plan for their employee health plan. Prior to January 2017, Kaiser HMO was not available for Santa Cruz county residents because there were no Kaiser facilities in the county. Beginning in 2017, Kaiser established a presence in Santa Cruz county. This was exciting news due to the historic imbalance of demand vs. availability for physician services in Santa Cruz county across primary and specialty care. Kaiser established three medical offices in Santa Cruz with access to primary care, urgent care, psychiatry and behavioral health, lab and pharmacy services. An agreement was set up with Watsonville Community Hospital for Kaiser physicians to see Kaiser-enrolled patients for Emergency Room services; a Kaiser birthing center was set up alongside the Watsonville hospital birthing center; and Kaiser hospitalists would see Kaiser patients at Watsonville for inpatient stays. Members could, and sometimes are required to, travel to Kaiser facilities in Santa Clara county.

Since 2017, retired UC members with Medicare eligibility (generally retirees aged 65 and up) could *not* select the Medicare-coordinated version of Kaiser HMO because approval was required by federal regulating agencies. This means that retirees enrolled in Kaiser HMO weren't able to continue with the plan upon turning 65. Also, active employees working past age 65 and enrolled in Kaiser had to select a new medical plan as part of the retirement process (Disruption).

Very recently, in early October, Kaiser Permanente was approved by CMS (Centers for Medicare Services) to serve Medicare-coordinated members residing in Santa

Cruz county. This was very welcome news and Kaiser has been communicating with the Medicare-aged county population that this plan, Kaiser Senior Advantage (a Medicare advantage plan) is available to them on 01/01/19. However, this raised a question as to whether UC retirees wanting Kaiser Senior Advantage could select this plan. The programming for the Open Enrollment website (AYSO) was not updated to accommodate Kaiser Sr. Advantage as a selection for Santa Cruz county addresses. I communicated to the OP HR/Benefits management team that there was print, digital, radio and television media communicating the availability of this plan and I requested a statement from Office of the President. I received a statement that UC was considering future options, but Kaiser Sr. Advantage would not be available as Retiree Open Enrollment election for Santa Cruz county residents. UC will assess for any enrollment opportunities after the new year. I am apprising you of the current-state of things. I have recommended to that UCOP vendor management group that paper Open Enrollment elections for Kaiser Sr. Advantage election by Santa Cruz county residents be accepted by RASC and I have expressed my deep disappointment with this response.

The UCSC Benefits Office is collecting the names and contact information for UC Retirees that contact us wanting to be enrolled in Kaiser Sr. Advantage on 01/01/19 so we can quickly distribute information to individual retirees should conditions change. I will keep this group updated with developments.

Having worked on campus for the last five years in a different capacity, I have been impressed by this fact time and time again. Last January, I was brought on as the new coordinator of the Retiree and Emeriti Center in conjunction with the center relocating to University Relations. Simultaneously, the center's office moved to the second floor of the Enterprise Technology Centre in Scotts Valley- which some may recognize as the old Borland complex. The move facilitates direct contact with the teams within University Relations, Staff HR, and the Benefits Office. The added advantage is the proximity to other departments that impact retirees.

Our current location is not easily accessible by drop-in visitors. To alleviate this sense of distance, I hope to connect with retirees through events, bi-monthly pop-up meetings around campus, and through the development of a more robust online presence that will be readily available no matter your current geographic location.

This is an exciting time for UC Santa Cruz retirees. We are at the beginning stages of developing a center that strives to provide a conduit between retirees and campus and a nexus for resources, and which celebrates the achievements of our retirees. I look forward to discovering what we can do together to make our center one that is as diverse and unique as our campus and the retirees we support.

Scholarship Committee Report

What an unforgettable surprise event for me which was added to the scholarship luncheon program on Wed. May 2 at the UCSC Arboretum. Many, many thanks for the lovely framed certificate signed by Chancellor Blumenthal and our Retirees President, Ilse Lopes, for my efforts related to the Retirees Association and campus. Also, thanks for the useful gardening tools to help me with propagating succulents to sell for military veteran student scholarships. I just hope to be worthy of Associate Vice Chancellor Steve Stein's kind words at the luncheon; you can't imagine how much his comments meant to me.

As of the end of September 2018, my records show a total of \$40, 229.58 in contributions for the Silver Slug Award Endowment for staff members and their dependents. This now has a market value of \$42,516. There is a total of \$160,300.78 in contributions for the UCSC Retirees Association Bruce Lane Memorial Endowment for military veteran students. This now has a market value of \$171,476. There is a total of \$1,541.83 in the UCSC Retirees Association Bruce Lane Current Year Fund for military veteran student scholarships.

October 2018 Annieglass Factory Tour



On Oct. 18, seventeen Silver Slugs met in Watsonville to see how the craftspeople at Annieglass turn large slabs of architectural window glass into beautiful and useful handcrafted glassware. After sternly (and humorously) warning us not to touch anything in the production area, because GLASS IS SHARP, our tour guide, founder Annie Morhauser's daughter Eva, took us through each stage in the process. Starting with cutting the glass, either by hand or by computerized water jet cutter, to the application of precious metal, painted decoration or etching, and then to the firing process. Glass pieces are heated to high temperature in electric kilns until they soften and "slump" over hand-made plaster forms. Before shipping, each piece receives a hand-etched signature and date. Annieglass recently celebrated their 35th year, and continues to offer new designs, as well as producing old favorite patterns. Their current factory incorporates their only factory outlet, selling current patterns and factory seconds, and a space offering art classes and wine tastings.
