## How We Advocate

In addition to social events, we do a lot of good. The RA is part of a UC wide consortium of Retirees Associations called CUCRA (Council of University of California Retiree Associations). Currently, Frank Trueba represents us at various systemwide meetings and committees to advocate for your benefits and health insurance. He has represented retirees during recent UCOP manager hirings to oversee the Retirement Administration Service Center. (RASC). Frank and other UCSC retirees and emeritus are active and effective systemwide. Frank, Lee Duffus, Roger Anderson and Todd Wipke have all worked to advocate for our benefits and to improve the services that we receive. In 2020, CUCRA conducted a survey of all UC Retirees in an effort to quantify post retirement engagement and just see what retirees are up to. ## The Retiree and Emeriti Center

The services and information that retiree's need can become difficult to navigate, so in conjunction with our colleagues in the Emeriti Association and the Committee on Emeriti Relations, we partner to develop and support the UCSC Retiree and Emeriti Center. The REC is a campus office staffed by the amazing Christy Dawley who connects to all the information and services that support retirees. #### We Give Scholarships

We have continued to fund and award scholarships for military veterans at UCSC and staff, as well as staff dependents in UCSC degree programs. These are the Bruce Lane Memorial Award and the Silver Slug Award, respectively. This year, 10 scholarship awards were given to veterans studying at UCSC. A staff member enrolled at UCSC, a dependent of a staff member and a dependent of a retiree each received a Silver Slug Award to help with their educational expenses. ## Preparing for an emergency

September is **National Preparedness Month** and a great time to take steps to prepare for disasters and emergencies that could happen at any time. Below are actions you can take now to help prepare.





## Make a Plan

Your family may not be together if an emergency strikes, so it is important to know which types of disasters could affect your area. Know how you'll contact one another and reconnect if separated. ## Build a Kit

After an emergency, you may need to survive on your own for several days. Being prepared means having your own food, water and other supplies to last for multiple days. A disaster supplies kit is a collection of basic items your household may need in the event of an emergency. Once you take a look at the basic items consider what unique needs your family might have, such as supplies for pets or seniors. ## **Emergency Alerts**

When emergencies strike, public safety officials use timely and reliable systems to alert the community. Santa Cruz Regional 9-1-1 uses the CodeRED community notification system to send important messages to residents, businesses, and visitors within Santa Cruz and San Benito Counties in the event of emergency situations or critical community alerts. CodeRED is capable of sending thousands of messages in a very short time based on geographic location of an incident to landlines, cell phones, emails, and via a mobile app. For more information or to sign up at:

## McIvor's Corner – News from the UCSC Benefits Office

Greetings from the UCSC Benefits Office. UCSC Staff Human Resources is phasing in return to campus offices and I am now working three days per week in the UCSC Scotts Valley Center location at 100 Enterprise Dr., with appropriate masking and social distancing requirements. As conditions change, UCSC will continue to follow guidance provided by the

county health officer. I expect that group meetings, such as Retiree Open Enrollment events, will continue to be virtual through the end of 2021. Speaking of Open Enrollment....

## Open Enrollment (OE) for the 2022 plan year Begins Thursday, October 28, 2021 at 8:00am Ends Friday, November 19, 2021 at 5:00pm

As mentioned above, Open Enrollment events for retirees will be held virtually in October and November 2021. Please note that Open Enrollment is ending early this year. For the past several years, OE ended on the Tuesday before Thanksgiving. OE for the 2022 plan year is ending on the <u>Friday before Thanksgiving</u>, to allow more time for processing OE elections. Open Enrollment details will be posted on UC Net (<u>https://ucnet.universityofcalifornia.edu/</u>) in mid-October.

Anthem and Dignity Health Reached Contract Agreement – If you are enrolled in a UC PPO plan carried by <u>Anthem Blue Cross</u>, you were notified that Anthem and Dignity Health failed to reach agreement on a contract before the contract period ended on 07/15/2021. Affected plans include <u>CORE</u>, <u>UC Care</u> and <u>UC Health Savings Plan</u>, as well as Anthem Medicare plans, <u>UC Medicare PPO w/ and without Rx and UC High-Option Supplement to Medicare</u>. Anthem Blue Cross and Dignity Health announced on August 14, 2021 that they reached agreement on a continuing contract, and the terms of the agreement are retroactive to July 15, 2021. This agreement returns Dignity Health facilities to Anthem health plans, while protecting affordability for members. This agreement is retroactive to July 15, 2021, which means any care provided to Anthem members over the last month will be considered In-Network, there will be no disruption of care.

UC is pleased to inform UC PPO members of this agreement. With the successful conclusion of contract negotiations between Anthem and Dignity Health, UC PPO plan members have continuing access to In-Network coverage for care received at Dignity Health facilities across California. **UC PPO plan members do not need to take action at this time.** All claims incurred since July 15<sup>th</sup> by UC PPO plan members were held by Anthem, as contract negotiations continued in good faith. Now that an agreement is reached, members' claims will be processed and covered by Anthem at the In-Network coverage level. UC PPO members shall be responsible for the In-Network member expense cost-sharing for services.

**Pension Income Statements** – If you receive monthly income from the UC Retirement Plan, you are likely enrolled in Direct Deposit and review your pension income statements on-line at UC RAYS. Pension income statements designate Employer Contributions (payments made by UC) towards the cost of monthly medical and dental premiums as "ER". "ER" is an abbreviation for "Employer" and indicates an expense incurred by UC. I have received calls from retirees concerned that amounts listed on pension income statements as "ER" were deductions from monthly pension income. This is to confirm that dollar amounts listed as "ER" are paid by the University, and are not deductions from monthly pension income. Our two scholarship endowment funds are steadily with the UC growing General Endowment Pool investments. These endowments are the source of the money for scholarships used to help our deserving military veteran students and Silver Slug students receive the education they strive for. Thank you so very much for contributing to these two very worthwhile funds.

Thank you also for contributing to the UCSC Retirees Association Bruce Lane Memorial Scholarship Current Year fund which provides funds for scholarships given in the <u>current</u> year.


