Caring for Caregivers

National Caregivers Day is the third Friday in February. Take a moment to show your appreciation for professional and volunteer caregivers making a big difference in the lives of others, even if that means for yourself.

About one-fifth of adults in the United States take care of a family member or friend who needs assistance. The role of caring for loved ones who are aging, sick, or disabled is rewarding and, at times, exhausting. For many, these strains have only increased during the pandemic when many support services were closed. According to the AARP and National Alliance on Caregiving report in 2020, an estimated 1 in 5 Americans, roughly 53 million people, provided unpaid assistance with daily living or medical needs to an adult or a child with special needs. The total is up nearly 10 million in comparison to 2015.

Findings in the 2020 survey report of UC Retirees by the Council of University of California Retirees Associations (CUCRA) showed that 53% of respondents have served as caregivers to a spouse, parent, grandchild, or other family members. Some respondents also noted that they helped out their children during the pandemic who had become unemployed or assisted with the care of grandchildren learning at home while their parents worked. Greetings from the desk of the UCSC Health Care Facilitator. Although we are in February already, I hope it's not too late to wish you a hearty Happy New Year! I'm sharing a few news items of topical interest below...

Anthem Members: Your Pharmacy Needs Your 2022 Rx ID Card to Cover Your Meds

A friendly reminder that as of January 1st, Navitus Health Solutions is the new pharmacy benefit manager for UC Medicare PPO and UC High Option Supplement to Medicare, as well as the non-Medicare plans: CORE, UC Care and UC Health Savings Plan. If you have not yet visited the pharmacy in 2022, please make sure to bring your new ID card to your pharmacy on your next visit. New ID cards with updated Rx information were mailed to home addresses in December and, for some UC retirees that experienced delays with their Rx benefit transition, continuing into January 2022. If you have questions about your prescriptions, visit the Navitus website at https://benefitplans.navitus.com/university-of-california or call the Navitus customer care team anytime day or night. Medicare members can call: 866-270-3877; Non-Medicare members call: 855-673-6504.

2021 Tax Statements

Printed 1099-R forms were mailed January 31, 2022, to the address you have on file. UC sends you a printed form unless you requested an electronic version. If you requested an electronic version, your 1099-R statements are available for viewing and downloading from your UC Retirement At Your Service (UCRAYS) account. Go to "Benefit Payments & Taxes" and click "Tax Statements". UC does not send tax documents by email or text.

Congratulations to UCSC for raising over \$94,000 in support of the Second Harvest Food Bank Holiday Food & Fund Drive. 100% of the funds raised go to providing food to distribute at partner agency locations throughout Santa Cruz County. Since March 2020, the need for assistance has increased and food distribution has doubled from 650,000 pounds per month to 1.2 million pounds per month. On average the number of Santa Cruz residents receiving food rose from 55,000 to over 100,000. Individual members of the UCSC Retirees Association and Emeriti Association together contributed \$1445 to the cause.
